FUTO WEARS A NEW LOOK

In the last edition of FUTO News (vol. 21 no. 2 of August 2001) we quoted the Vice-Chancellor as saying that the Governing Council had considered plans to commence the landscaping of some sections of the Campus and that this would be done in phases.

We are happy to note that the landscaping project has begun in earnest and that the Federal University of Technology, Owerri is now wearing a new look. Starting from the main gate, it is easily noticeable that one is approaching a serene and decent community, a citadel of learning. The main approach is being decorated with beautiful flowers, well laid out lawns and pedestrian walk ways.

At the Senate Building which is nearing completion, the surrounding bushes and hedges have been bulldozed and now the seat of the University has become a beautiful edifice to watch from several points across the Otamiri River.

The J.T. Useni Centre for Transport Management Technology, the extension of which was completed recently, has been transformed into a centre of attraction by its beautiful surroundings.

Similarly, the bushes around the School of Engineering and Engineering Technology (SEET) building and the Library block have disappeared. One can easily sight the students' hostels, the library, SAAT building and the Medical Centre from the ground floor of SEET building.

Again, the bushes along the major roads have been pushed some metres backwards to provide a clearer view for both motorists and pedestrians.

Sequel to the one year anniversary of Prof. J.E. Njoku as Vice-Chancellor, FUTO News sought the people's opinion on the journey so far. The people responded through their leaders. In this edition we bring you the comments of the leaders of various unions on campus:

COMARDE J.C. AYOKA, OUTGOING SUG PRESIDENT

FUTO is generally backward in infrastructure. Within the past one year however, the rate of development has been quite impressive with the completion of projects like the Lecture Theatre and Useni Building. Students are also happy for the erection of a sporting complex, but we would like an access road to be provided to link the hostels to the complex.

The landscaping is refreshing as it gives our University the desired look and makes the environment more friendly. Students will be happy if the landscaping is extended to the hostel areas.

There is also great improvement in the provision of seats for lecture halls, electricity and water supply as well as better hostel sanitation. Other areas of improvement are the provision of drugs at the health centre, the extension of operating hours at the Library to 8.00pm as against 4.00pm.

Victimization of students has also stopped and the Students' Union now has greater freedom. However, the students want more independence and a clear distinction between the Students' Union and the Student Affairs unit so that they will be freer in organizing their own affairs.

The transportation system should be made to incorporate students by providing shuttle services from the school to the neighbouring villages where a good a imber of students live.

There has been remarkable increase in physical infrastructure in the last one year both in terms of completion of on-going projects and new ones. We are quite impressed that students no longer use the road in front of their hostels as toilet, which shows that their hostel condition has been improved.

The provision of sporting facilities is a welcome development. We are also happy that the SOSC Building is being rehabilitated. But we are worried about whether the resurfaced FUTO-lhiagwa road met its specifications.

In all, quite a lot has been achieved in one year, but as academics we would like to take these developments as a start. ASUU is looking forward to the take off of new projects such as the SLTTP and new SAAT buildings. We also want another academic staff office block like we used to have at the temporary site. We hope that Government will increase the level of capital funds, because Government needs to invest a quantum of funding before it can expect universities to be self-sustaining to a certain level.

We are happy about recent acquisitions in the Library, but we look forward to an electronic journal service. There is also need to refurbish 'attruments in the laboratories.

We are particularly h ppy that this administration has laid down criteria for appointment of Heads of Departments. It is a master piece. This will make people feel the enormous responsibilities attached to Headship of Departments.

Promotions have also come along as and at when due and this administration has cleared the augean stable. The Vice-Chancellor should release more professorial chairs.

More people have gone on conferences and this is a remarkable development because it encourages publications. We are also grateful to the Vice-Chancellor for clearing the arrears of excess workload allowance. We look forward to prompt payment of excess workload allowance from now on and more training on computer literacy.

NEW PROJECTS TAKEN OVER

FUTO'S scanty infrastructure on Tuesday, August 21, 2001 received a boost with the taking over of the Extension o. J.T. Useni Centre for Transport Management Technology, and the re-surfaced FUTO Internal Road by the University Management led by the Vice-

Speaking at the handover ceremony of the Useni Building, Prof. Njoku said that the main Useni Block is an endowment to FUTO as a Centre for Transport Management by J.T. Useni Committee of Friends during the 1996 Convocation.

He explained that the extension became indispensable not only because the main Useni block was a mockery of what was originally conceived but also because it would reduce the office accommodation / lecture hall needs of the School of Management Technology (SMAT).

The Chief Executive paid special tribute to the Education Tax fund (ETF) which made available to FUTO during the 2000 fiscal year N20 million which realized the project as well as some computer

Useni Building received the attention of the Vice-Chancellor as he promised to undertake the landscaping and planting of ornamentals as well as creating a link path to the 500 capacity lecture theatre commissioned recently by this administration.

Earlier, the Ag. Director of the Physical Planning and Development Unit of FUTO, Engr. Dr. H.I. Agha expressed happiness that the new block comprising 5 offices, 2 large classrooms and 4 toilets were realized on schedule.

Formally handing over the keys of the Useni Building to the Vice-Chancellor "to the glory of God", the Project Contractor, Chief Lemmy Akakem thanked 'the FUTO Management for the opportunity given him to showcase his construction acumen in FUTO for the first time, adding that he

would always be available to serve FUTO.

Chief Akakem announced his intention to package something for FUTO as a token of his interest in the development of sports.

While inspecting with FUTO Management staff the almost 3 Kilometers of FUTO internal road from Gate I to Gate II – resurfaced by Obenard (Nig) Ltd, the Vice-Chancellor said that the very bad state of the road made its repair inevitable, and the university had to dip hands into internally generated revenue to execute the project.

Prof. Njoku said that the road required constant maintenance for the work done to stand the test of time. Hodisclosed that Managemen might consider a recourse to the defunct Public Works Department's (PWD) method of deploying road workers on the road on regular basis to ensure proper maintenance.

Finally, the Vice-Chancellor thanked the contractor, Mr. J.N. Ogu, "for a good job" which was in line with Council's observation when they inspected the repairs few months ago. He not I that it was the first to be realized among the projects awarded within the same period.

The project contractor thanked the Council and FUTO management for giving him the opportunity to perform, pledging that he is always disposed to serve FUTO in the construction sector.

The hand-over ceremonies were well attended by Deputy Vice-Chancellors, other Principal Officers and

Deans of Schools.

SPORTS FACILITIES

In a similar vein, two newly completed sports facilities (a twin lawn tennis and a volley ball courts) were on Tuesday September 11, 2001 taken over by the Management of the Federal University of Technology, Owerri led by the Vice-Chancellor, Prof. J.E. Njoku.

Speaking at the occasion, the Vice-Chancellor noted that the projects were embarked upon in December 2000 to meet the recreational needs of students and staff and to have some facilities in place for the hosting of the NUGA zone D preliminaries early in the year 2001. He indicated that the projects which were financed through internally generated revenue, were expected to be completed in April 2001 but were delayed by problems associated with the site and early coming of the rains.

Prof. Njoku expressed his delight that FUTO students now have additional recreational facilities to ease off academic tension and keep them off from anti-social behaviours such as cultism. He announced that his administration would in due course provide more sports facilities to boost sports in FUTO because "all work and no play makes Jack a dull boy"

In the meantime he hopes to turn the sports complex into a beehive of activities by opening up an access road from the students hostels to the arena, landscape and beautify the surrounding and deploy security men to guard the facilities.

In his own remarks earlier, the Director of K-- Mart Construction, Chief Brown Mbila thanked the Governing Council and the Management of FUIO for giving them the opportunity to showcase their expertise. He highlighted the problems which resulted in the delay of the take-off and completion of the ject such as difficulty in locating the site, early or us as well as scarcity of the appropriate paint for outing the surface of the courts.

He advised that adequate security be provided around the sports arena to keep off herdmen whose cattle sleep on the surface of the courts and drop dung indiscriminately. The take over of the sports facilities was witnessed by a number of University functionaries among whom were Engr. Dr. H.I. Agha, Director of Physical Planning and Development; Prof. O.E. Okorafor, Director of Academic Planning and Development; Dr. D.N. Oquoma, Aq. Dean of Student Affairs; Mr. D.O. N. Nwokeocha, Chief Accountant; Mr. J. E. Nwagu, Deputy Universty Librarian and Mr. J.U. Nnabuihe, Public Relations Officer.

PROF. NJOKU TAKES STOCK OF HIS ONE YEAR AS VC

The Vice-Chancellor, Prof. J.E. Njoku declared peace as the bedrock of his developmental agenda in FUTO. The Vice-Chancellor made this known in his address to the 10th General Assembly held on August 7, 2001 to mark the first anniversary of his administration.

Academic development with its direct linkage to infrastructure has been a major focus of the Njoku administration. The Vice-Chancellor took pride in the recent rating by the NUC which placed FUTO in the 5th position of all 36 universities in the country. Priority he said, had been given to the provision of adequate offices, classroom, laboratory and workshop spaces.

This was to create conducive environment for effective

learning. He and teaching inherent the acknowledged potential of enhancing teaching and research as well as FUTO's international image and exposure through its current academic linkages with CUTEC of Germany and the University of Arkansans in the United States of America.

Indeed a novel idea to stimulate academic excellence was announced by the Vice-Chancellor. That stemmed from the Federal Government's approval for the construction of a 'scholarship' hostel in FUTO for students with CGPA of 3.5 and above. Also made known was the proposal by the Education Tax Fund to finance a building for SAAT as part of its 2001 grant. Similarly, he expressed his sincere thanks to FUTC Alumni Association for its pledge to build a Post Graduate Hall for the University.

NUC DELEGATE COMMENDS FUTO

Dr. (Mrs.) M.B. Adeniran, a representative of the National Universities Commission (NUC), recently on a routine visit was greatly pleased with the evident progress achieved in FUTO.

She noted that FUTO had the greatest student enrolment amongst the Federal Universities of Technology and had witnessed remarkable growth in its undergraduate programmes.

However, she pointed out that the Post Graduate School needed to be reinvigorated since it was the epicenter of academic development in the university, for through it, knowledge and teaching skills are developed and strengthened. She stated that her mission was to ascertain a status report of the problems that affect the academic system as it relates to FUTO and to evaluate problem sclving methods "all geared towards improving the quality of our products."

In his response, the Vice-Chancellor, Prof. J.E. Njoku welcomed Dr. (Mrs.) Adeniran and noted that her visit was the first to FUTO since he became the 4th substantive Vice-Chancellor.

Prof. Njoku drew the attention of Dr. (Mrs.) Adeniran to the deleting of names of students of FUTO's Department of Project Management Technology (PMT) by the ITF. He described PMT as an amalgamation of Engineering and Management, for which basic entry requirements included credits in Mathematics, Physics and Chemistry. He regretted that it had proved difficult convincing the NUC

on the engineering inclination of the Project Management programme in FUTO and need for inclusion of PMT students for industrial training. massive release of funds to the University would be actualized, for it would in turn lead to rapid development in FUTO. The Vice-Chancellor also revealed

The Vice-Chancellor reminded the NUC representative of the proposal already submitted to the NUC for a new School of Health Sciences and sought the benefit of their assessment. He also reiterated his intention to expand some programmes with submission already made to Senate. Inadequacy of classroom and office spaces primarily due to excruciating financial difficulties, has continued to pose a major problem in FUTO, the Vice-Chancellor remarked adding that only N32 million out of N100 million approved for 2001 had been released so far.



MEET FUTO 4TH DEPUTY VICE- CHANCELLORS

In our last edition of Futo News, we highlighted the appointment of the fourth set of Deputy Vice-Chancellors of the Federal University of Technology, Owerri (FUTO). We now bring to you their detailed personality profiles.

PROFESSOR ADIVE **BONIFACE IKELI UDEDIBIE** (DVC ACADEMIC)

Professor Adive Boniface Ikeli Udedibie was born on August 12, 1950 at Aguleri in Anambra East Local Government of Anambra State.



He had his primary education at St. Princis Pennary School and St. Joseph's Princery School all in Aguleri, where he abtained the First School Leaving carrieste in 1960. He obtained the West This an School Certificate in 1971 in Division I from St. Mary's High School Subsequently, he Hite-Ukpa admission into the esteemed University of Nigeria, Neakka where he obtained a B.Se degree in Agriculture with Second Class Honours, Upper Division in 1975. He later proceeded to the renowned Cornell University, Ithaca, New York, USA for his Post graduate studies from 1978 - 1982 and subsequently acquired M.Se and Ph.D degrees in Animal Science. From 1976 -1978, he worked as Research Officer II at the National Veterinary Research Institute, Vom and in 1982 he was elevated to the rank of Senior Research Officer, During this period, he was responsible for the management of the swine and dairy farms of the fisherie as well as teaching the Higher

National Diploma students of the College of Animal Health and Husbandry of the Institute. He took up appointment with the Federal University of Technology, Owerri in August 1984 as Lecturer I and rose to the rank of Professor in October, 1995.

In addition to his teaching services, he has been involved in the University Administration. He has served as Chairman and member of several School and University Committees from 1985 till date. He was Head of Department of Animal Science and Technology from 1989 to 1998; Dean, School of Agriculture and Agricultural Technology from 1998 to July 2001 and Chairman, Committee of Deans from January to July 2001.

Prof. Udedibie is a member of many learned societies among which are: Nigeria Society for Animal Production, Science Association of Nigeria, World Poultry Science Association and New York Academy of Science.

He has executed a good number of local and international research projects, prominent among which was a research on the use of Jackbean and Swordbean for livestock feeding which was sponsored by the International Foundation for Science (IFS), Stockholm, Sweden.

Prof. Udedibie has over 50 journal articles as well as over 45 technical/conference papers to his

He is fellow of the Nigerian Society for Animal Production and has appeared in the 2000 edition of 'Marquis Who is Who in the world.'

Prof. Udedibie is actively involved in several community based activities within and outside his home

FUTO DESERVES SPECIAL TREATMENT - VC

The Federal University of Technology, Owerri (FUTO) deserves special treatment in the allocation of capital fund for the development of infrastructure. Prof. Jude Njoku, the Vice-Chancellor of the University made this assertion while meeting with the NUC Task Force on the closure of satellite campuses led by Prof. Placid Njoku.

The Vice-Chancellor recalled that FUTO lost its temporary site to Imo State University without any special grant from the Federal Government for its hurried relocation to the permanent site. For this reason, he said, FUTO has remained the most infrastructurally underdeveloped Federal University in the country.

He therefore advised the NUC to properly address the issues that led to the establishment of satellite campuses.

The Vice-Chancellor then used the opportunity to brief the NUC team on the steps taken by his administration in compliance with the directive on closure of satellite campuses, adding that the Senate of the University was still discussing appropriate measures to ameliorate the hardship faced by students already enrolled in its closed down centres.

Speaking earlier, the Chairman of the Task Force, Prof. Placid Nioku indicated that the team was in FUTO to ascertain the University's compliance with the Government directive closure of satellite campus adding Satellite Campuses become controversial due to the proliferation of such campuses in the country and the subsequent

churning out of sub-standard graduates who could not defend the certificates awarded

to them. He contended that the universities contravened the law establishing them by leaving their location and embarking on new programmes outside their mandate and entering arrangement with businessmen to commercialize university degrees and certificates. Consequently, Government was left with no option than to close down such centres which according to him were mostly located in "obscure cornershops".

He indicated that Government was working out a number of alternatives satellite campuses such distant learning, weekend/ evening programmes and sandwich/residency

programmes.

Prof. Nioku advised universities to be more innovative in their quest for alternative sources of revenue.

The Task Chairman promised to convey the feelings of FUTO on special grant for infrastructural development to the Executive Secretary of NUC.

Other members of the NUC delegation were Dr. I. Abdullahi, Mr. M. Ndanusa and Mr. Victor Onuoha.

Also present at the meeting were Deputy Vice-Chancellors, Principal Officers, Deans, Directors and Heads of Departments.

CLOSE DOWN YOUR STUDY CENTRES- VC WARNS CO-ORDINATORS

The Vice-Chancellor of Federal University of Technology, Owerri Prof. J.E. Njoku had an urgent meeting with all the Co-ordinators of FUTO Satellite Campuses in the country on September 12, 2001. Addressing the Co-ordinators, the Vice-Chancellor directed them to immediately comply with the directives of the National Universities Commission to close all the study centres by removing their sign boards and sending the students on holidays with immediate effect, while the University looks into ways of ameliorating the hardship on students already enrolled in the programmes.

The Vice-Chancellor read our NUC's letter to that effect and warned that whoever runs any study centre in the name of FUTO will be arrested by the Police. He told the Co-ordinators that the University Senate which handles all readenic motters is currently putting heads regellier towards coming out with alternative strangements.

One of the Co-ordinators asked if the diaversity could integrate the study centre students into FUTO and sought advice on how best to bandie students' reaction. In his reply, the Vice-Chanceflor said "the university is alive to their plight but they should first comply". On andy reactive remittance into FUTO account, the ba-Chanceflor said records available proved that a childrenames were deeply indebted to FUTO. The Make assured the Co-ordinators that FUTO will soon cone out with a centralized admission policy which will protect the interest and welfare at the students.

The Registrar was mandated to issue a communique to all the affected students through the centre co-ordinators, explaining the position of things and efforts being made by the University to address problems arising from the clause of the satellite campuses.

An extraordinary feat was achieved recently with the FUTO based networking of the first two, and subsequently other computers in the advanced laboratory of the FUTO Computer Centre.

This major breakthrough was pioneered without external assistance, by the Director, Computer Centre, Prof. P.B.U. Achi with the assistance of Mr. H.N. Iwuoha, a Principal Technologist, and Mr. C.A. thedioha, an Assistant Chief Analyst and Programmer.

This was made known by Prof. Achi while conducting the FUTO News crew round the facilities in the Computer Centre recently. He stated that this achievement was a direct dividend of the Research grant given to him and his team. He explained that he had been working on the project for over a year and commended all his staff who worked painstakingly.

Undaunted by obstacles, but holding fast to the promise of Networking, which provided the enthusiasm any scientist could ask for, Prof. Achi remarked that "you can never be sure of what you can do until you try", adding that the exploit will project the image and glory of the Federal University of Technology, Owerri.

He declared that since technology is not usually divulged

In the Computer Centre, "we continually generate money for the University and are also struggling to build a computer maintenance crew and to commercialize the use of our colour printer, scanner and other services."

The Director re-thrmed the ability of the centre to meet its objectives of not only providing computer appreciation programmes for students but also ensuring that they are

computer literate.

He was particularly claied by the successful conclusion of computer training, as 201 for the 2000/2001 Harmatian semister anspite of the madequate ratio of about 25 computers to 3,000 second year students. The major hindrance he said, was the absence of a generator. He requested the Vice- Chancellor to give priority to the argent provision of a generator to the centre in the light of the collection power supply from NtPA. He also lamented the non-release of the ordance of the approved Research Grant to invovide cables and other materials to facilitate the networking of more computers in the centre. He also requested for prompt repairs of broken down computers and purchases of several new ones aimed at producing computer literate students worth their saft.

Prof. P.B.U. Achi expressed profound gratitude to the Vice-Chancellor for his zeal and moral support during the course organized in February 2001, and yearned continuing



In keeping with the manimous decision at the 9th prematriculation meeting between the University Management and highlighted other pointers to the poor infrastructural state of the university as the lack of an Administrative Block, madequate

Parents/Guardians of FUTO students, the Parents/Guardians, Management forum was formally inaugurated on Saturday, August 11, 2001.

While addressing the occasion, the Vice- Chancellor, Prof. J.E. Njoku stated that the purpose of the forum was to get Parents/Guardians as co-partners with the University Management to fashion out appropriate solutions to the problems of the University. He said it was his belief that the implementation of mutually agreed solutions would be better welcomed by students and thus minimize crists within the University.

The Vice-Chancellor drew the attention of the parents and guardians to the numerous problems of the University. He revealed the fact that the Federal University of Technology Owerri was the most infrastructurally under-developed Federal university in Nigeria. This he said was evident in the serious dearth of Academic staff offices, classrooms, lecture halls, laboratories, workshops and adequate library building with enough reading spaces. The Vice-Chancellor

Hostel accommodation, paucity of sporting facilities, sub-standard catering facilities, absence of telephone facilities and complete absence of staff quarters which has denied the university the full complement of university community.

He also informed the parents/guardians that there was complete absence of urban water supply to the university, as the university provides its water through boreholes powered by

standby generators.

Prof. J.E Njoku however noted with delight that despite the backwardness in infrastructural development, the Federal University of Technology, Owerri, has maintained academic excellence and its graduates have continued to show remarkable performance in both the public and private sectors of the Nigerian economy.

The Vice-Chancellor hinted the parents and guardians on some of the steps being taken by the University Management towards remedying the university's poor infrastructural state. Prominent among such efforts, he said, was the involvement of the private sector. This he said has yielded some fruit as a private establishment TUNJI COKER

FOUNDATION has opted to assist in building 25 hostel blocks of 100 rooms each on the basis of a 40%: 60% cost sharing ratio between it and the university respectively. On the terms of the agreement, he disclosed the FOUNDATION was to recover its financial input over a period of twenty five years through hostel accommodation fees paid by students.

Prof. J.E Njoku then affirmed the University Management's belief that there are various ways and means by which the parents and guardians can significantly contribute development of the university. Such contributions he said could be in form of donations towards funding of the university projects, provision facilities transport and sporting facilities, endowment of professorial chairs in disciplines of interest, sourcing linkages for the University in its areas of expertise, as well as using their various relationships and connections with government and profit making circles to canvass for special government support for the University in terms of funding.

their response, In parents/guardians thanked the Vice-Chancellor and the University Management for making the forum a reality. While adopting the Vice-Chancellor's address as a working document to be studied and deliberated upon at the next meeting of the forum, the parents/guardians acknowledged that the issues raised therein were such that needed urgent attention, especially the case of hostel accommodation. They expressed willingness in assisting in combating some of the problems and made on-the-spot cash donations. They also appointed a nine-man Protemexecutive to run the affairs of the forum pending a formal election. The team was made up of

At the meeting which was presided over by Mr. Chidi Nkwopara, the Forum's Public Relations Officer who stood in for the protem Chairman Chief E.C. Eluchie, the Protem Executive presented three proposed projects for the consideration of the forum namely: purchase of two Mercedes 1414 Buses, erection of a lecture hall and erection of a workshop.

After exhaustive discussions on the feasibility, utility and durability of each of the three proposals, the forum agreed that the most pressing need of the students, apart from hostel accommodation, was the provision of more lecture halls. It was noted that university authority through the Governing Council was already addressing the hostel needs through involvement of private developers on 'build operate and transfer' basis.

The forum further agreed that each parent would contribute a minimum sum of N5,000.00 per student per year over a period of two years to enable the forum raise money for the project which was estimated to cost over N60 million. was also agreed that the contribution would take effect from January 2002 and would be applicable to subsequent new intakes.

UBA, ROMAC DISCUSS WITH FUTO

The vision of the 7th Governing Council of the Federal University of Technology, Owerri to encourage private sector investment in addressing the infrastructural needs of the University has begun to yield dividends.

Mr. Charles Ohamara, the Group Head-Public Sector of the United Bank of Africa PLC recently led a three man delegation to acquaint the Vice-Chancellor with the willingness of UBA to participate in the infrastructural development programme of FUTO. Mr. Ohamara emphasized that UBA took special pride in its reputation as a customer friendly bank and therefore reckoned on its predisposition to source cheapest funds.

He pledged the Bank's readiness to specifically finance the staff accommodation needs of the University adding however that the extent of the facilities to be provided by UBA would be predicated by FUTO's counterpart funding (excluding land).

Another private developer, ROMAC Utilities Ltd, a consortium of companies engaged in engineering and architectural services with beadquarters in Owerri was represented by its Chairman, Hon. Engr. E. Emenako. He indicated that his company had access to local and international finance bodies and could invest as much as N10 billion in the construction of students' hostels and University staff quarters.

Hon. Emenako indicated that NICON would in our all projects to be constructed by his company. In the event of failure to redeem after 50% volume utilization of the project, all statutory rights of occupancy would be transferred to NICON after 24 months.

in his remarks, the Vice-Chancellor, Prof.
3.6. Njoku stated that the meeting was informed by the decision of FUTO Management to review proposals before presentation to the Governing Council. He noted that the cash flow difficulties faced by the University would not permit the full mortgage of its Federal grants, more so to avoid the crippling of other capital projects.

In reaction to the Vice-Chancellor's invitation for comments, it was observed going by the proposals that the University was inclined to default even before project completion. The meeting therefore called for a phased BOT arrangement in preference to repayment of all commitments to ROMAC within two years.

The University proposes to build 100 units of duplexes, 150 units of 4 bedroom bungalows and 200 semi-detached bungalows for its professorial, senior and junior staff quarters respectively.

The Vice-Chancellor also revealed that FUTO is ranked third Nigerian among Universities in terms of expertise in computer and communications technology and stressed the need for the University to make the best use of its expertise. He challenged the already identified experts to bring up younger generation of experts to take over from them and promised to provide more office and computer facilities for the NUNct office.

Earlier in his welcome speech, the Chairman of FUTO NUNet Committee, Prof. Johnson Ejimanya commended the Chancellor for his commitment to NUNet and requested him to earnestly pursue the Computer Networking of the University and subsequent connectivity to the INTERNET.

He noted that the Unit had made significant impact on the University Community by creating awareness and desire among staff to acquire e-mail addresses. He however, indicated that the major problems of NUNet were the epileptic power supply by NEPA and the unsteady functioning telephone system in Imo State and requested the Vice-Chancellor to consider the provision of an alternative power supply.

The Vice-Chancellor, Prof. J.E. Njoku has indicated the intention of the FUTO Management to reward speedy grading of examination scripts and timely submission of results by academic staff. The Vice-Chancellor gave the hint while declaring open a seminar on 'The Conduct and Management of Examination' for all academic staff from the rank of Graduate Assistant up to Senior Lecturer which was held recently at the 500 Capacity lecture Theatre, FUTO.

He stressed the importance of such a seminar which had been overdue in view of the large volume of results correction brought to the Senate and the delay in processing of students' results for approval by the Senate. The Vice-Chancellor suggested that technologists should be included in future.

Earlier in his welcome address, the Director of Academic Planning and Development whose office organized the seminar stated that the aim of the seminar was to ensure the conduct of hitch free examination and conformity with the approved grading system so that students would graduate with classes of degrees which they actually merited.

Four eminent professors presented papers on various aspects of examinations. Prof. E.O.I. Banigo, one of the pioneer professors in FUTO and former Vice-Chancellor of Rivers State University of Science and Technology, Port Harcourt and currently Chairman, Business Committee of Senate took the first shot. In his paper titled "Examination Management and Supervision" he emphasized the need for proper and

effective co-ordination among the various Departments/ Units and individuals involved with the conduct and management of examinations.

He called for the provision of more conducive environment for writing examinations in order to avoid overcrowding and minimize examination malpractices.

Prof. A.I. Ukoha, former Dean of School of Science, spoke on "Continuous Assessment." He contended that continuous assessment as an integrated part of the teaching process was imperative. He further opined that students should be at liberty to have access to the result of their semester tests before going into the semester examination.

Prof. Ukoha stressed the need for proper record keeping by those involved in examination conduct and administration and for lecturers to make proper use of the marking scheme. "Calculation of students grades is an easy task which involves simple arithmetic operations of addition. multiplication and division of numbers." So said Prof. U.B.C.O. Ejike, incumbent Dean School of Science and first Deputy Vice-Chancellor FUTO. His paper 'Calculation of Grade Point Average (GPA)' was presented with mathematical precision and tabular illustrations of how students' grades should be computed from year one to graduation. He noted that error in calculating students grades

may affect their class of degrees.

The immediate past Deputy Vice-Chancellor (Academic), Prof. M.U. Iloeje took his paper, from the legal angle. He vividly presented the statutory roles of various bodies individuals in the conduct and management of examinations. In his words "the legal power to make arrangements for examinations up presentation of results for consideration and approval by the Senate belong to the School Boards of Studies acting through respective Boards Examiners whose members shall by law be appointed by the Senate."

Prof. Ilocie emphasized that proper channel of presenting examination results to the Senate must not be contravened, adding that moderation of examination results is clearly the duty of the Board of Examiners and not that of the Head of Department alone.

FUTO PLEDGES COMMITMENT TO NIFST

The Vice- Chancellor of the Federal University of Technology, Owerri, Prof. J.E. Njoku has declared the University's readiness to strongly stand behind the Nigerian Institute of Food Science

and Technology (NIFST).

Prof. Njoku disclosed this while speaking at the opening of a two-day workshop on 'FOOD PROCESSING **OUALITY** ASSURANCE AND LEGAL REOUIREMENTS' organized by NIFST Owerri Zone at the FSP Hall Owerri. Prof. Njoku lamented that the food crisis in the country had not addressed properly successive governments, adding that NIFST has a great role to play in resolving the food crisis. The Vice-Chancellor noted with pride that FUTO is highly respected in the Food Science and field of Technology and promised to beef up department for efficiency.

In his remark, the Chairman of the Seminar, Mr. U.J Ukpabia of the National Root Crop Research Institute (NRCRI), said that the workshop was basically organized to enlighten and sensitize the public on the expectations and requirements involved in food processing towards production of wholesome food.

According to the keynote address presented by Mr. Okpara, Director of Livestock on behalf of the Honourable Commissioner of Agriculture Imo State, the food industry plays vital role in the development of a viable economy. He however regretted that on the basis of Human Development Index (HDI) which considers the nutritional status of the citizens and level of her food security, Nigeria is rated very low.

The Commissioner of Agriculture therefore called for

serious sensitization on issues relating to responsibilities of food agencies as regards food quality and management, certification and professionalism in food industry in Imo State.

According to the communiqué signed by the Zonal Co-ordinator of NIFST, Dr. O.S. Eke at the end of the workshop, the need for enlightenment campaign aimed at improving the much designed food processing and techniques was emphasized.

Agencies such as NAFDAC and Standards Organization of Nigeria (SON) were enjoined to be resolute and also to foster cooperation with professional institutes such as NIFST.

Papers were presented by other distinguished food scientists among whom were Prof. J.C. Okaka of Enugu State University of Technology (ESUT), Dr. C.N. Ubbaonu of Federal University of Technology, Owerri (FUTO) and Mrs Merey Obidigbo of National Agency for Food and Drug Administration and Control (NAFDAC).

Others were Dr. W.I. Obioha of the Federal Polytechnic Nekede, Owerri and Mr. Chidi Osuagwu of the Alvan Ikoku College of Education, Owerri.

The attendance of the workshop clearly captured how the public feels about the theme. Participants were drawn from students and of staff the Department of Food Science and Technology of all the Institutions of higher learning within and outside Imo State. Environmental Health Officers, Food Processing and Packaging Agencies as well as Food Industries within Imo State were not left out.

VC URGES FUTO STAFF

TO REDUCE STRESS

o "We must stay alive as strong and r healthy people to work and achieve the peak of our chosen career and retire. This behoves us to create a conducive atmosphere in our homes and offices in FUTO". The Vice-Chancellor, Prof. J.E. Njoku so declared at the opening of the 'Stress Management Seminar' for Principal Officers, Deans, Directors and Heads of Departments of FUTO on August 1, 2001 at the Villa Mariae Guest House, Owerri.

Dr. E.C. Agulanna, the Principal Consultant of Veedac Management Consultants, organizers of the seminar, stressed that the essence of the seminar in relation to FUTO staff, whose jobs were more mental than physical, was to protect the brain from the dangers of stress. In his lead paper on "The Concept of Stress; Organizational Causes and Consequences', Dr. E.C. Agulanna defined stress as " a situation when we perceive events as straining our coping capacities and threatening our well being." He enumerated the major causes of stress at work as work overload, inadequate material variables resource, physical (temperature, noise ctc.) noninvolvement in decision making process, and unclear job description and evaluation criteria. Others are unfair performance appraisal and forceful retirement. The ugly consequences include loss of working days caused by stress induced ailments, high medical bills, decreased mental alertness and loss of physical stamina.

Dr. C.C. Ekennia's lecture on 'Domestic Stress' aroused great interest. "Domestic stress is most devastating . . . considering the fact that the family is the nerve centre of all human institutions upon which the survival of society depends", he explained. The more adjusted a home is , the less stress generated in the home, says his theory.

Dr. Ekennia's findings from a multi-component research indicated that family power ran in a sequence, from the man in the first twelve years of marriage to the woman and children thereafter.

He asserted that reckless use of family power by the man disequilibrates the harmony in the home, creates a hostile home environment, alienates him from his wife and children which concomitantly introduces devastating stress.

To enhance a man's longevity and fulfilment particularly later in life therefore. Dr. Ekennia advocated investment in the wife in the early years of marriage as social security. He emphasized the need to create a fertile emotional elimate and to treat the wife with understanding, patience, love and care, recognizing the fact that she largely determines the success of the marriage and of the children too.

The high point of the 2-day seminar was the realization of the inevitability of stress in life which confirmed that perception was the key that determined our ability to cope or collapse. Here Dr. E.C. Agulanna reveals eight (8) stress busters:

- -Take deep breaths, exhale repeatedly.
- -Discuss / share your problems.
- -Take a time out.
- -Exercise regularly.
- -Say No to some of the excessive demands on your time.
- -Soothe the nerves with music.
- -Pray always.
- -Embrace Humour.

After the presentation of papers and discussion session, Dr. (Mrs) G.G. Agulanna also of the Veedac Management Consultants administered stress tests on the participants.

COMMUNITY REQUESTS VC TO CALL STUDENTS TO ORDER

The Vice- Chancellor of Federal University Technology, Owerri, Prof. J.E. Njoku recently invited the Executive of Eziobodo Union for dialogue over complaints of anti-social behaviour of some FUTO students living among the villagers. In his opening remarks, the Vice-Chancellor who was represented by the Vice-Chancellor Deputy (Academie) Prof. A.B.I. Udedibie told his guests to regard FUTO students living in their midst as their own children and wards, and to report any misdeed on the part of students FUTO authority for immediate investigation appropriate action.

The Vice-Chancellor described the location of the University as a blessing to the host communities and assured them that FUTO would continue to give them favourable consideration in the areas of employment and minor jobs

In his speech the President-General of Ezicbodo Town Union, Mr. V.C.A. Ekeugo, who led the delegation, thanked the Vice-Chancellor for inviting them and apologised for sending their complaint to the state Governor without first informing the Vice-Chancellor. He stated that the community was made to believe that the university had no effective control over students living outside the campus, adding that the degree of offence warranted

their action in order to avoid a breach of peace in the community.

Не informed the Vice-Chancellor that some FUTO students in black uniforms were sighted heading for the farms and the next day what looked like an initiation ground was discovered. That, he said, was regarded as a taboo by the villagers. The President-General requested the Vice-Chancellor to call students to order as the community would not tolerate any further desecration of their farm lands.

Commenting on the report, the Ag. Dean of Student Affairs, Dr. O.N. Oguoma told the delegation that all students of FUTO were under the authority of the University wherever they reside, as long as they remained students of FUTO, adding that they were expected to be found worthy in both character learning before being admitted into the degrees of the University. He urged the community to always inform the University authority of my misconduct by FUTO students and suggested that landlords of FUTO students should enter into written agreement with their student tenants and copies of such agreement made available to the University.

Contributing 10 the discussion, the Ag. Chief Security Officer, Mr. Simon Gokop suggested that the community Vigilante Group should always furnish FUTO with vital information concerning the

activities of EUTO students.

In his closing remarks, the Deputy Vice-Chancel or (Academic) advise 1 to Town Union to maintain constant communication with the University.

FUTOLA CALLS ON

THE WICE- CHANCELLOR

A 19 man delegation of the **FUTO** Landlord Association (FUTOLA) on Tuesday, September 25, 2001 called on the Vice-Chancellor of the University.

The leader of the team and FUTOLA Chairman Chief Sir A.N. Ekeopara, in a brief remark stated that the purpose of the meeting was strengthen the peaceful relationship existing between FUTOLA and the University Community. He said that FUTOLA as a partner in progress with FUTO deserved to be informed on happenings in the University that would need the association's attention. Chief Ekeopara assured the Vice-Chancellor that FUTOLA is a peace-loving association that believed in dialogue as means of resolving her differences with any party.

In an address read on behalf of the association by its Vice-Chairman. Deacon G.N. Onyemechara, the FUTOLA solicited more employment quota in the junior staff cadres and scholarship for their sons and daughters. The association warned about the presence of a group it referred to as 'dissident element' which it believed was not working for the interest of the University. It then called on the Vice-Chancellor to ask the group to either stop their activities or merge with FUTOLA they must operate. association pledged its unalloyed lovalty to FUTO and affirmed that it was against any form of breach of peace in the campus.

While responding, the Vice-Chancellor promised that

with time, the presence of the University would be more felt by the host communities. He however informed the association that FUTO can not guarantee the provision of pipe borne water and tarred roads for the communities. On the issue of employment and scholarship, the Vice-Chancellor assured FUTOLA that their sons and daughters who qualify would be duly considered when such vacancies and services available.

The Chief Executive condemned the hostile attitude of some members of the host communities which manifested in the illegal harvesting of cassava from the students' demonstration farm. an act that culminated in the suspension of the programme. He pledged that FUTO on its would do everything possible to maintain peace with the host communities. He also promised to look into the complaints of the collection of illegal rates/fees by Students' Union Government from various categories of vendors on campus.

Other university functionaries present at the occasion were the Deputy Vice-Chancellor (Academic) Prof. A.B.I. Udedibie; Deputy Vice-Chancellor (Administration) Prof. I.C. Ogwude; Director, Office of University Development, Engr. G.I. Nwandikom and the Public Relations Officer, Mr. J.U. Nnabuihe.

DIALOGUE - WE TELLS OLA

The Vice-Chancellor, Prof. J.E. Njoku has implored representatives of the Original Landlords Association (OLA) to always seek resolution of grievances with the University through dialogue. He gave this advice while welcoming the OLA delegation led by its Chairman, Chief F.O. Okorocha, on a visit to FUTO.

He drew the attention of the Association to the fact that FUTO operated under difficult conditions and called for patience and understanding on the part of the Original Landlords Association.

The Vice-Chancellor observed that the Association had not maintained regular communication with the University and so was bound to be full of misgivings. He placed it on record that "I do not deceive anybody ... let us be genuine and straightforward".

He therefore urged, the Association to seek relevance in the affairs of the University. He maintained that no vacuum existed in the University in the absence of the Vice-Chancellor since the University had other Principal Officers who acted for the Vice-Chancellor in his absence.

In his reply to complaints made by the Association employment matters; the Chancellor vehemently stated that he had implemented his policy of giving priority to host communities in employment and patronage of minor contractors. He confirmed recruitment of indigenes who had met the employment criteria. The Vice-Chancellor wondered how illprepared candidates were expected to through the burdle competitive written exams and oral

interviews. "We must be seen to do the right thing", he declared. He challenged the Association to bring forward names of recommended and appointable candidates that were denied employment.

regards As cults, enjoined the Chairman to forward the names of any FUTO student caught 'red handed' in cult activities for outright expulsion. In another vein, he reiterated his decision to maintain a neutral stand in any disagreements between associations of host communities, but also advised them to avoid internal wranglings which do not augur well for peace and development.

The Chairman of the Original Landlords Association, Chief. F.O. Okorocha pledged the support of the Association and craved the opportunity to contribute its quota to the progress of the University.

Chief Okorocha had expressed displeasure with the non-employment of natives of host communities in recent recruitment exercises in FUTO. He also frowned at the delay in the payment of local contractors and also narrated a case of cult activity involving some FUTO students.

The 22 man delegation representing Eziobodo, Ihiagwa and Obinze communities included Rufus Ejimogu, the Vice-Chairman and J.A. Nwachukwu, the General Secretary.






